

LIMITED WARRANTY

INDOOR/OUTDOOR CARPET AND TILE

MOHAWK CARPET DISTRIBUTION, LLC (the Manufacturer) provides a limited warranty on its Indoor/ Outdoor Carpet tile and Broadloom products as set forth herein. This Warranty is a legal document and sets out the sole obligations of the Manufacturer so please be sure to read this Warranty in full. No person, party, or entity is authorized to modify or extend the Warranty without express permission of Manufacturer. The limited warranty gives you specific legal rights and contains the entire scope of Manufacturer's responsibilities, and you may also have other rights which vary from state to state.

Manufacturer's limited warranty for the Indoor/Outdoor carpet tile and broadloom is as follows:

- Ten years from the date of initial purchase; and
- Applies only to (i) manufacturing defects (those that are due to Manufacturer's defective workmanship or materials), (ii) damage that occurs during freight/shipping, and (iii) failure to comply with accepted order parameters.

In the case where you believe the applicable Manufacturer product is within the scope of this warranty, Manufacturer will, as its sole liability and obligation, accept the applicable product as a return and provide a complying product free of charge. Except expressly stated in this Warranty, no other form of compensation, beyond replacement of product subject to the terms of this Warranty, is owed and is thereby disclaimed. The remedy contained herein is the sole and exclusive remedy for any and all product claims.

EXCEPT THOSE STATED IN THIS WARRANTY, MANUFACTURER MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED. EXCEPT WHERE PROHIBITED BY LAW, ALL OTHER WARRANTIES - INCLUD-ING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PAR-TICULAR PURPOSE-ARE EXPRESSLY DISCLAIMER AND THEREBY EXCLUDED.
